Introduction

We appreciate that you may have some concerns about returning to College as part of the roadmap out of lockdown. This information pack lets you know what you can expect when you come to College. The measures that were in place in the Autumn term to make the College as safe as possible for you and others still exist with a number of further additions so please read the information in this booklet carefully so that you understand what is required of you.

The College's approach to managing and mitigating the risks of COVID19 infection or transmission is to:

- maintain 2 metre social distancing principles between adults, and between adults and young people to protect those more at risk from COVID-19
- reduce the numbers of interactions between groups and individuals by adapting timetables and using seating plans; and adapt shared facilities such as Learning Resource Centres and Café and catering offered
- improve ventilation in classrooms
- enable enhanced hand hygiene and implement enhanced cleaning activities;
- ensure all staff and students are aware of the need for increased care and to avoid coming into College if they feel unwell.
- introduction of 3 lateral flow tests in the two weeks prior to timetables beginning on site on Monday 22 March
- issue home testing kits after the third supervised on-site test
- require the wearing of face coverings whilst on site or display an exemption card as agreed with College
- follow the guidelines of hands, face, space

It is the responsibility of all students, staff, and visitors to ensure the procedures set out in this document are followed.

Please wash or sanitise your hands when you arrive and regularly during the day. You will be required to wear face coverings in college. Please bring suitable face coverings with you. Unless exempt, you should now also wear a face covering in lessons as well as elsewhere on campus. Please wear clean clothes each day. Due to the need for ventilation in all rooms, you should bring a warm top or dress warmly depending on the weather.

In classrooms your contact will be limited to those who are seated next to you. You should not change seats without the agreement of your teacher. When in corridors and during breaks maintain your social distance from others and avoid mixing with others who are not in your classes. You may be reminded to increase the distance between yourself and others. Please follow the oneway system indicated on the floors. Please return home to study rather than staying on campus after your classes if it is possible for you to do so.

What the College is doing to protect you and your teachers?

Coronavirus specific risk assessments of each campus have been completed, reviewed by an external expert consultant and appropriate adjustments implemented. All risk assessments have been revisited and amended as necessary following the most recent government guidelines published in March 2021.

The College has amended class timetables to reduce the number of students on campus and to reduce the risk of transmission between groups. You will also be asked to observe a set seating plan in lessons to limit the number of your close contacts (those with whom you spend time at less than 2 metres distance).

Prior to your return, a thorough clean will have been completed of each campus. This includes the application of a 30-day Microbe Shield Surface Sanitiser to all desks, worktops, workstations, keyboards, door handles, door plates, handrails etc. This specialist product provides a long lasting anti-viral barrier designed to kill bacteria and viruses. The Microbe Shield Surface Sanitiser will continue to be reapplied every 21 to 28 days.

During term time, routine and enhanced cleansing of all major touch-points will continue throughout the day; hand sanitiser is widely available along with spray disinfectant and paper towels to complete spot cleaning as required.

you will observe:

- Wall mounted hand sanitiser stations across all campuses.
- "One Way" or "Keep Left" systems to aid the flow of traffic and reduce crowding
- Each classroom has a 2m demarcated zone for teacher use only to ensure teachers and students maintain social distance, so students can learn safely.
- Student Card Register pads near to classroom entrances to enable students to register attendance without entering the 2m demarcation zone.
- Installation of fire door retainers, where permitted by fire regulations, allowing for the automatic holding open of fire doors to reduce the need for you to touch and open the door (but which will close automatically in the event of a fire).
- Installation of Perspex barriers in specific locations to reduce the risk of infection where students routinely interact with college staff members or other students; e.g. at Receptions, Student services desks etc. (and between IT equipment where it is not possible to avoid a seating arrangement where students would be facing each other)
- Removal of as much soft furnishings as possible to create extra space and reduce the risk of infection
- Creation of COVID cleaning top-up stations across each campus, stocked with spray disinfectant and paper towels to be accessed by staff if or when needed.
- Wipes and/or appropriate cleaning materials will be provided in rooms where sharing of equipment or normal curriculum specific activities make this necessary for example in IT suites and practical subject areas.
- Staff and students wearing face coverings unless exempt.

Students with medical conditions seeking exemption from wearing a face covering, should go to student services desks to request an exemption card that will need displaying on lanyards

What the College needs you to do to keep yourself and others safe

Current guidance remains that younger people are at less risk from COVID-19 than adults and that normal class sizes are permitted for these groups. In class, students are not required to maintain social distance from each other but must be seated facing forwards and must observe set seating plans to reduce your number of close contacts. Once outside of your classroom you need to maintain distance from others as much as possible. You should also maintain distance and observe all public health COVID measures designed to reduce transmission of the virus when outside College, such as maintaining social distance, minimising contact with others outside of your household or support bubble, and using face coverings where necessary.

You should participate where possible in the mass testing and subsequent home testing for students. **Anyone who has previously received a positive COVID-19 PCR test result should not be re-tested within 90 days of that test, <u>unless they</u> <u>develop any new symptoms of COVID-19</u>. If, however, you do have an LFD test within 90 days of a previous positive COVID-19 PCR test, for example, as part of a workplace or community testing programme, and the result of this test is positive, you and your household must self-isolate in line with public health guidance.**

Following completion of 3 Lateral Flow Device (LFD) Tests on site, as per government guidance and until advised otherwise, you will be asked to and provided with home testing kits to test yourself twice a week at 3 to 4 day intervals. This will help to reduce the risk that you or others who may have caught COVID but do not have any symptoms unintentionally spread the COVID virus in College or in your community. Everyone taking part further decreases the likelihood of further disruption to your education.

This asymptomatic testing programme does not replace current guidance for those with symptoms or those identified as a close contact of a positive case. Anyone with symptoms, whether they have had a LFD test or not, should book a free NHS PCR test and follow government self-isolation guidance until the results of their test are known. Testing is an <u>additional</u> measure and does not replace or reduce the need for existing measures in place such as regular handwashing, using face covers and social distancing.

The following required actions should be observed by all Students in order to protect themselves and others from Coronavirus:

• Minimise contact between individuals and maintain social distance.

- Students must endeavour to remain 2m apart from adults at all times (Adults must endeavour to remain 2m apart from each other)
- Students should maintain social distance from each other when not in the classroom or using shared Learning Resource Facilities and should minimise mixing with others outside of your class groups.
- Students should normally go home as soon as possible once their lessons for the day have been completed. We appreciate that some students will prefer or need to study in college and you will therefore be able to book a study space in the Learning Resource Centres which are located on each of our three campuses.

(Please be aware you may be asked to take a step back should you be too close to others)

• Follow and encourage others to adhere to any "one way" or "keep left" conventions: All Students are expected to follow keep left or one way systems and you will be challenged and reminded to observe these if these are not adhered to.

Use enhanced personal hygiene measures

Everyone must clean their hands thoroughly, more often than usual, and must ensure good respiratory hygiene by promoting the 'catch it, bin it, kill it' approach. Hand sanitiser is widely available throughout the campuses. All students will receive a personal bottle of sanitiser during induction.

- Everyone should practice good hygiene by:
- Regularly washing hands with soap and water for at least 20 seconds or using hand sanitiser provided if soap and water is not available.
- Coughing/sneezing into a tissue, or crook of arm, not into your hands (should sneezing into hands occur, you are requested to wash your hands with soap and water for at least 20 seconds.
- Avoiding touching eyes, nose and mouth with hands.
- Avoiding contact with anyone with respiratory illnesses of any kind
- Do not share drinks containers, food or cigarettes and e-cigarettes

Those at heightened risk or with underlying health conditions for you and your family

You should discuss with your Student Support Tutor (A-level Students) or Progression Specialist (Vocational Students) if you are at heightened risk from COVID (for example if you have a health condition that places you at specific risk or are from a BAME background). If you don't know who your Student Support Tutor or Progression Specialist is (if you are joining the College or are unclear for any other reason) please e-mail info@shrewsbury.ac.uk so that we can support you further. The most important thing to remember is the frequent washing of your hands and maintaining social distancing.

Are you or those in your household/support bubble well enough for you to attend college?

On a daily basis, for the safety of yourself and others, you must ensure you and those in your household/support bubble feel well enough for you to attend college. If you or they are displaying any symptoms of Coronavirus you must not attend College even if your own LFD test was negative. Instead, the person with COVID symptoms must book a PCR test and inform the college of the results.

Anyone who tests positive must still self-isolate for 10 days from when their symptoms started.

If someone in your household has tested positive you must self-isolate for 10 days from when the first person in your home started having symptoms, even if you do not have symptoms and even if your own COVID LFD test or PCR test is negative.

The main symptoms of coronavirus

The main symptoms of coronavirus are:

- **High temperature** this means you feel hot to touch on your chest or back (you do not need to measure your temperature)
- New, continuous cough this means coughing a lot for more than an hour, or 3 or more coughing episodes in 24 hours (if you usually have a cough, it may be worse than usual)
- Loss or change to your sense of smell or taste this means you've noticed you cannot smell or taste anything, or things smell or taste different to normal.

Stay at home if you have symptoms (self-isolation)

If you are displaying symptoms, call NHS 111 who will advise;

- To book a PCR test (this will either be completed at home or you will be asked to attend a Coronavirus testing site) Stay at home and do not have visitors until you get your test result – only leave your home to have a test.
- Anyone you live with, and anyone in your support bubble, must also stay at home until you get your result.
- Anyone who tests positive must self-isolate for 10 days from when their symptoms started.
- If someone in your household tests positive you must self-isolate for 10 days from when the first person in your home started having symptoms, even if you do not have symptoms.

Report your absence

All students/carers must report absences, preferably by 10am by emailing **absence@scg.ac.uk** - remember to include both your name and if possible, your student ID number. If you have COVID symptoms, please contact the College COVID tracker by e-mail **covidtracing@shrewsbury.ac.uk**. You will be asked to provide relevant information and provided with guidance and support on what to do next.

Obtain a PCR Test and notify the College of the result

PCR Tests can be booked online through the NHS website, or ordered by telephone via NHS 119 for those without access to the internet.

You are to inform the college immediately of the results of a test by emailing **<u>COVIDtracing@shrewsbury.ac.uk</u>**:

If the PCR test result is negative;

• You may return to College. The College will not request evidence of negative test results, or other medical evidence before welcoming you back after a period of self-isolation.

If the PCR test is positive;

- You should inform the College immediately using the normal Absence process and should also notify the College's COVID Tracker by emailing <u>COVIDtracing@shrewsbury.ac.uk</u>
- You must isolate in line with public guidance

What should I do if I become unwell with COVID symptoms during the day at college?

Should you start to have COVID symptoms during the day;

- You / someone must report this to a college staff member who shall contact reception and a first aider will assist you. You will then be isolated in a dedicated room until arrangements can be made to get you home safely.
- You will be issued with guidance on what to do next: you will need to
 - book a PCR test (this will either be completed at home or you will be asked to attend a Coronavirus testing site) Get a free NHS test to check if you have coronavirus - GOV.UK (www.gov.uk)
 - self-isolate and do not have visitors until you get your test result only leave your home to have the PCR test
 - Anyone you live with, and anyone in your support bubble, must also stay at home until you get your result.

What should I do if another student becomes unwell with COVID symptoms during the day?

Should someone else display symptoms during the day.

• You / someone must report this to a college staff member. The Staff member call a first aider who will assist the unwell individual. They will then be isolated in a dedicated room until arrangements can be made to get them home safely. During this period the First Aider will issue guidance to the affected individual on what to do next and notify the relevant staff to arrange for cleaning and to determine what further action is needed.

What should I do if someone in my household has COVID symptoms?

You must self-isolate and must not attend College in the following circumstances:

- If someone you live with, or someone in your support bubble, has symptoms; you must not attend College until that individual has been tested <u>and their</u> <u>result is negative</u> (if the individual is not tested you have to complete the required self-isolation period - currently at least 10 days).
- If someone you live with, or someone in your support bubble, tests positive then you must not attend College until you have completed the required self-isolation period (currently at least 10 days)
- If you're told by NHS Test and Trace that you've been in contact with a person with coronavirus then you must not attend College until you have completed the required self-isolation period (currently at least 10 days).

Travelling to and from College

You will need to think about the best way to travel into and from college.

If possible, avoid using public transport by using your own car, having a lift from a family member, walking or cycling. The college has space to lock your bike securely, please bring a bike-lock or chain and padlock of your own.

It's important to remember the social distancing rules when walking and cycling.

If you need to use public transport, then please follow the rules of wearing a face mask during the journey. These can be purchased online or you can make one yourself. If public transport is the only way you can travel to and from college, please bear the following in mind:

Arriva buses timetables may be subject to being rescheduled so please check the timings for your bus.

Arriva buses have reduced the number of people using each bus and may display a 'Bus Full' sign, if you see this for the bus you are intending to travel on, it will carry on past your stop unless someone requests to leave at that stop. If a bus stops and lets passengers off, the driver will only allow the same number of people to board, once the maximum numbers are reached, it will leave without allowing all the people to board. You will need to wait for the next bus.

This is the general guidance from Arriva for using their buses, more information can be found on their website <u>https://www.arrivabus.co.uk/Midlands/</u>

The guidance currently requests:

- Face coverings must be worn at all times* when travelling
- Please sit one per row
- Pay by contactless or use the app if possible
- Cash will be accepted but exact fares only, no change given
- Plan your journeys in advance

*unless exempt



If using the Colleges dedicated bus services

- you will also need to wear a face mask during the journey and respect and obey any instructions provided by the driver.
- You should try to minimise the number of other students you mix with for example by sitting in the same seat or next to the same people.


Help keep our buses safe


For people planning a journey



Stay safe: be a responsible traveller, plan ahead if you need to travel and don't travel if you're feeling unwell



Exercise while you travel: walk or cycle for short journeys if you can.



Avoid Busy Periods: try not to touch surfaces like buttons, doors or your face and try to avoid eating.



Respect our staff and other passengers while you're travelling.

Use of College Minibuses

Please be aware that any users of college transport / external college buses other than the driver are to use a face covering and windows are to be opened as much as reasonably possible to allow for good ventilation

Seat/s directly behind any college staff members / driver are not to be used and a do not sit here notice will be displayed

You will be asked to sanitise your hands prior to boarding.

Each minibus shall have a cleaning pack with in it, consisting of spray disinfectant and paper towels to allow for wiping down of touch point areas following every use, similarly external college bus providers will clean their buses after every trip.

Please remember to avoid touching any unnecessary surfaces and to wash / sanitise your hands after using a college bus or minibus.

Using the campus

Please wear your student ID badge and lanyard, making sure it is always visible. If you have forgotten your ID, depending on which campus you are attending, you will need to go to reception to obtain a one day temporary ID card. All three campuses have door access control systems fitted which means your ID badge allows access through external doors. Any students attending site without an ID badge can be issued with a temporary day ID badge, but this must not be a regular occurrence. If you are issued a temporary lanyard, please be aware that these will be quarantined upon return before they are reissued. If you have lost your ID please contact reception to get this replaced as normal.

Each campus has adopted a keep left system by default with one-way systems where indicated to ensure social distancing is maintained. Please ensure you follow the signs at all times. Anybody not following the implemented systems will be challenged and requested to do so. There will be signs around the campus reminding of the need to maintain social distancing.

At service areas there will be taped lines for standing back from a desk and any member of college staff. Please adhere to the markings and follow the queuing guidance to maintain distance from others. College staff offices/areas will display maximum room seating occupancy numbers on doors. This is for college staff information, however, if you visit or enter these areas please take care to maintain your social distance from others.

Ideally we would ask that you wait until you leave the site before smoking but if you do need to use the smoking area at London Road campus, please be aware the space is only available to smokers and that everyone must continue to maintain social distance from others. You must not borrow cigarettes or lighters/matches from other individual and you should not share lit cigarettes. You may be asked not to use the area if it is busy and be asked to return later, please follow any such direction from college staff remembering it is for everyone's safety.

English Bridge and Welsh Bridge campuses are both no smoking sites, please leave site before smoking. Please do not congregate at any entrances to campuses and allow sufficient room for others to pass at a safe social distance. Please also ensure you maintain social distancing measures, any individuals not observing these guidelines will be challenged and politely requested to do so.

Spitting is not allowed on campus. Any such behaviour will be challenged and reported to an appropriate member of college staff if observed.

If you need to dispose of a face covering please use general waste bins - do not place your unwanted face coverings / disposable masks in recycling bins. If you have used a face covering on your way to College or for any other reason you should also carry a small bag or container in which to store your used face coverings. This will minimise the risk of any cross contamination from the outside of your face covering within your bag/pocket and onwards elsewhere.

The key points to remember are:

- Do not touch the front of the face covering, or the part of the face covering that has been in contact with your mouth and nose.
- Once removed, store reusable face coverings in a plastic bag until you have an opportunity to wash them. Wash your face covering regularly and follow the washing instructions for the fabric. You can use your normal detergent. You can wash and dry it with other laundry. You must throw away your face covering if it is damaged.
- If the face covering is single use, dispose of it in a general waste bin. Do not put them in a recycling bin.
- Make sure you clean any surfaces the face covering has touched using normal household cleaning products. If eating in a café, for example, it is important that you do not place the face covering on the table.

Within each classroom setting the following changes have been made;

- The setup of rooms has been designed so that students sit in rows by default so that students do not face each other. This means students are sat next to each other facing the front. Where this is not possible (for example where IT equipment or fixed furniture prevents this) screens have been installed to reduce the risk of transmission. In a room where it is beneficial to remain in a horseshoe arrangement, students must not sit at the corners facing the side of another student.
- A 2m demarcated "teacher only" zones have been marked out on the floor in standard classrooms specifically to enable teachers and students to maintain their social distance.
- Student Card Register pads have been located near to the classroom entrance to enable students to register attendance while maintaining social distance.

All teachers are required to keep a student seating plan for each room they teach in. This will be required by the college should a student experience symptoms of Coronavirus (COVID-19). Please ensure you sit in your allocated space for each session throughout the year.

Sufficient windows should be opened to maintain a flow of fresh air. Ventilation systems or air conditioning have been set not to recirculate air but to draw fresh air in. Where this is not possible these systems have been turned off.

Issues where students fail to observe social distancing guidance and fail to respond positively to reminders or requests should be reported to an appropriate member of college staff. Any students failing to adhere to these guidelines may be asked to leave the campus under the Student Conduct Policy Annexe COVID-19 and the student conduct policy will be instigated when required.

Food services at college

To limit congestion in food service areas we suggest that you bring your own food/ drink for the day. The Hub at London Road and Bridges cafés in Welsh and English Bridge will be open each day and will be able to provide a grab and go service only. Social seating areas will be limited and you are advised to use outdoor space to eat if the weather is dry. Please do not rearrange any furniture within these areas as they have been placed specifically to maintain social distance measures and remember to wash your hands before and after eating. The Hub and Bridges cafés are open 0800 - 1500.

To reduce numbers within The Hub and cafés we shall also be opening pop up shops around the campuses, which will also be providing a grab and go service.

The locations and opening times of the pop-up shops are;

London Road

The coffee bar - 0800 - 1830 (1500 Fridays)

Prompt corner - 1000 - 1100 / 1200 - 1330 (Performing Arts building)

Clayton hall pop up shop - 1000 - 1100 / 1200 – 1330 (accessed via the external stairwell from patio outside the Hub Café area)

Engineering pop up shop - 1000 - 1100 / 1200 - 1330

You will need to pay for your food and drink by using a contactless payment method rather than using cash.

Water coolers / fountains are currently unavailable, the refilling of water bottles will be possible at the following locations;

London Road

- The Hub main counter
- The coffee bar counter
- The Darwin coffee shop
- Prompt corner shop (performing arts block)

English bridge

Bridges café

Welsh bridge

Bridges café

All food/drinks will be served using disposable containers, but you won't be charged the normal surcharge. Please ensure you keep the college tidy by putting all containers in the bins after use

Food outlets will not be available until week commencing 22 March 2021

Using shared facilities

Toilets will have posters reminding you about hygiene; please remember to wash your hands frequently during the day for at least 20 seconds.

To enable social distancing to be maintained college staff are to only use staff toilets or accessible toilets. Students will continue to use all other toilets.

Hand dryers have been switched off and replaced by paper towel dispensers.

The Learning Resource Centres (LRC) will be open for students as a study space, to allow use of the computers and to allow all to borrow books and equipment. Books and LRC equipment returned shall either enter quarantine for 72 hours before being made available again or be wiped down with disinfectant. Any equipment with a face-to face seating arrangement has been fitted with a Perspex screen to limit the risk of transmission.

Lifts are for use by those with a disability or condition which makes use of stairs problematic. Only one person at any time should use the lifts unless a user has to be accompanied, in which case a face shield must be worn by the college staff assisting.

Shared Equipment/resources

The college has installed sanitiser stations near every MFD printer and copier, please ensure you sanitise your hands before and after use of this equipment.

Where possible, we will ensure students are allocated the same piece of equipment (PC/Mac, Camera, hand tools etc.) for the day, and limit or avoid sharing equipment unless it is cleaned between users. Classrooms with shared IT equipment and practical curriculum subject areas will be provided with wipes/ additional cleaning equipment. Students should assist with cleaning any shared equipment they use.

If you are concerned that another user may have used the desk/workstation you are about to use then wipe down the desk, keyboard and mouse. If using a shared desk/workstation please also wipe down the desk, keyboard and mouse once you have finished using it.

Please do not touch notice boards.

Conduct and expectations

In order to allow the opening of college, everyone needs to be mindful of behaviour, conduct and attitude to each other whilst on site so that we can keep everyone safe. It is very **important we all act safely and considerately when on campus**.

Please make sure that you:

- Comply with all signage whilst on the college campus
- Comply with the need to social distance from others and adults, including in Reception, café, outdoor spaces, classrooms, LRC and workshop areas.
- Make sure that when you cough or sneeze you use tissues or the crook of your arm and ensure you wash or sanitise your hands more regularly.
- Politely challenge anyone who you see not complying and report this to staff if necessary.


In the event of any student not upholding the rules and guidance in this document, they may be asked to leave campus and the student conduct policy will be used when required. Failure to comply with COVID measures will be deemed a serious matter and may result in disciplinary action up to and including exclusion.

Evacuation Processes


In the unlikely event of a fire alarm you will need to exit the building through the nearest fire exit (Any current one way and keep left systems do not apply in these circumstances; the aim is to get you out quickly and safely). When exiting the building, try to maintain a social distance from others and also remember to maintain a social distance from others when assembling at the Fire muster points.

At the London Road Campus only, please be aware that muster point C has been created and is situated within the overflow car park to the rear of the Darwin Building. Those exiting from the HE Centre, or Darwin Building should now use muster point C.

Revised London Road Campus fire assembly points




Welsh Bridge Campus fire assembly point
