**Employer Privacy Notice****An Employer of a student/apprentice at the College**

As an Employer of a student/apprentice at the College we collect, store and use your information for the purposes of managing communication with you regarding the student/apprentice you employ.

**The information we collect about you and why we collect it**

In order to communicate with you will collect your name, email address, phone numbers, position within the organisation, and the nature of your relationship with the student/apprentice. This information may be collected from you, your organisation, or the student/apprentice at point of application or enrolment.

**The legal basis on which we collect and use your personal information**

We process this information on one of two legal bases; public duty or our legitimate interests.

For apprentices:

- we have a public duty to engage with employers to ensure that apprentices achieve their framework/standard in full; and
- to be able to do so, we need to hold details of individuals that employ them.

For employer supported students:

- we have a legitimate interest to engage with employers to ensure that students achieve in full; and
- to be able to do so, we need to hold details of the individuals that employ them.

**How long we keep your personal information**

We keep your personal information in line with our Data Retention Policy. This is 3 academic years, from the final academic year in which the information was collected.

**How we share your personal information**

We do not share your personal information with any other organisation.
