Parent, Guardian, Next of Kin Privacy Notice

A Parent, Guardian, or Next of Kin of a student at the College

As a Parent, Guardian, or Next of Kin of a student at the College we collect, store and use your information for the purposes of managing communication with you regarding the student you have a relationship with.

The information we collect about you and why we collect it

In order to communicate with you we will collect your name, email address, phone numbers, and the nature of your relationship with the student. This information is collected from the student at point of application or enrolment. Information may also be collected should you choose to engage with any of the College's online events, this may include: Name, Email, Questions you ask.

For Next of Kin we maintain this information for contact in case of an emergency situation involving the student.

The legal basis on which we collect and use your personal information

Except for the Next of Kin, we process this information on the basis of our legitimate interests:

- we have a legitimate interest to engage with parents and guardians to ensure students achieve their full potential; and
- to be able to do so, we need to hold details of those parents and guardians.

Where we contact a Next of Kin we do so in the vital interests of the student.

How long we keep your personal information

We keep your personal information in line with our Data Retention Policy. This is 3 academic years, including the academic year in which the information was collected.

How we share your personal information

We do not share your personal information with any other organisation.
