The College delivers programmes through a franchise arrangement with Staffordshire University http://www.staffs.ac.uk/. The programmes that are delivered and the benefits for students are detailed annually in the HE Prospectus and on the College's website where course specifications are available to download.

The College is also in receipt of direct funding from Office for Students (OfS) which enables them to offer programmes awarded by BTEC Pearson– HNC's and HND's.

In May 2018 the College was visited by a Quality Assurance Agency (QAA) team who reviewed their Higher Education provision (Foundation Degrees, Degrees, HNC/D and Teacher Training qualifications). The QAA review team formed the following judgements about the higher education provision at Shrewsbury Colleges Group.

- There can be confidence that academic standards are reliable, meet UK requirements, and are reasonably comparable with standards set and achieved in other providers in the UK.
- There can be confidence that the quality of the student academic experience meets baseline regulatory requirements.

	All HE Students are able to access careers guidance through the Agency based in the Enterprise Centre. Students studying on programmes delivered through franchise are also able to access careers provision at Partner Universities.
	The College delivers a number of programmes which have a placement aspect and some HE students are observed in their own work based setting. For these programmes, having appropriate work or voluntary activity in place at the beginning of the course is a condition of entry - this is detailed in the entry requirements for our programmes.

	On some programmes, students are required to undertake a work placement or work based activity during the course. These placements or activities can be negotiated by the College, in partnership with the learner. In instances where, for reasons beyond the learner or Colleges control, external opportunities cannot be identified or fall through, alternative College based opportunities are found. The College is also committed to providing wider work related opportunities to all students. These can include: • Guest lectures from industry specialists and trips and visits • Assessment briefs which focus on simulated work based scenarios. • Opportunities to engage in personal and professional development planning. • Opportunities to develop skills required for selfemployment/ freelancing as appropriate. • The development of transferable skills- e.g. communication, numeracy and ICT.
