## Terms of Reference for Quality, Standards and Curriculum Committee (Appendix 2/16)

1.7 To ensure Higher Education provision at Shrewsbury Colleges Group meets and exceeds the needs and expectations of students, employers, partner universities and other stakeholders.

## Student Outcomes – Shrewsbury College (Appendix 3/16)

The Vice-Principal, Quality and Curriculum Management submitted updated student outcomes for Shrewsbury College and highlighted the following points from the detailed report:

- Data was still incomplete due to a number of factors including external verification dates being postponed, and learner queries on individual aims
- Retention was 90.1.% overall, an improvement up by 3.6% on the previous year
- Strong performances in Health and Social Care and Engineering but concerns regarding Public Services which had a low entry criteria
- Results for GCSE English and Maths remained challenging and showed a link with attendance those who gained a C or higher in English attended 88%, in maths, this was 84%.
- Apprenticeship data not complete currently 71.2% and likely to show an improvement on 2014/15.
- Higher Education had a 94.7% achievement overall.

The Vice-Principal referred in particular to GCSE English and Maths and confirmed that best practice, cross teaching and lesson observation would be put in place between the Colleges to improve results.

In response to a Governor query, she gave clarification on sub contract provision and undertook to explain this is more detail at the next meeting of the Committee.

## Outcomes for Shrewsbury Sixth Form Students 2015/16 (Appendix 3/16)

The Head of Shrewsbury Sixth Form College submitted student outcomes for Shrewsbury Sixth Form College and highlighted the following points:

- 47.5% A level students achieved A\* B grades priority is to increase on this
- Value Added (ALPS) moved up to Grade 5 (satisfactory to good)
- GCSE recognition that outcomes were on cohort where average GCSE score had fallen from previous years with increase in students from disadvantaged postcodes
- Good outcomes for P.E. and psychology which had previously been areas of concern

- AS results excellent
- Recovery plans in respect of some subject areas to be submitted to future meetings
- Attendance figures above the national average benchmark

#### Student Voice Report – Student Exit Survey 2016 (Appendix 4/16)

The Vice-Principal, Quality and Curriculum Management, submitted a report giving a summary of information relating to learners views gathered by the Exit Survey conducted at Shrewsbury College during May-June and which would contribute to the quality, annual planning and self-assessment cycles.

The Head of the Sixth Form College confirmed that student surveys were completed by students during tutorial sessions and that there had been a high response rate of 950 in 2015/16.

### Teaching and Learning Assessment (Appendix 5/16)

The Vice-Principal, Quality and Curriculum Management submitted a report on assessments carried out at Shrewsbury College and delivered by full, part-time and agency staff. She emphasised that it was important to grade appropriately and not to inflate grades in any way which could be questioned. The Principal agreed and stated that there must be correlation between assessment grades and outcomes.
